

Registration in accordance with Article 6 of Regulation (EC) No 852/2004 on the hygiene of foodstuffs

Pursuant to Article 6 of Regulation (EC) No 852/2004 on the hygiene of foodstuffs, food business operators **must notify** the competent authority of the establishments under their control.

According to Article 3(2) of Regulation (EC) No 178/2002, food business operators include all profit or non-profit enterprises involved in activities related to the production, processing and distribution of food. "Food" does not include, for example, live animals that are not prepared for human consumption or unharvested plants.

If a food business operation consists of multiple establishments, a separate notification must be submitted **for each establishment**.

If any information is revised, a change notification must be submitted immediately.

Notes

A. Responsible authorities

According to Article 3 Para. 1 No. 3, Para. 2 and Article 4 of the German Health Services and Consumer Protection Act (GDVG), the district administration offices (district administrative authorities) and independent cities are, as food monitoring authorities, responsible for registration and recording.

B. Registration of food business operators (Article 6(2) of Regulation (EC) No 852/2004)

1. Except in the case of No. 2 (below), the form provided (see annex) must be used for registration.
2. An official business registration and the "Registration form for the registration/authorization of feed and food businesses" submitted in connection with the multipart application are valid as a registration.
3. The authorities shall ensure that the data from the business registration is forwarded immediately to the internal body responsible for registration.
4. Information that does not correspond to the data in the form (annex) must be successively supplemented by the competent authorities.
5. The registration does not replace otherwise required notifications and applications for permits, approvals or authorizations.
6. If the competent authorities become aware from other sources of new food business operators or relevant changes to already registered food business operators, they shall arrange for these to be registered if necessary.

C. Registration of establishments (Section 10 (1) AVV RÜb)

Establishments not subject to registration under B.1 but subject to registration under Section 10 (1) AVV RÜb* must be recorded in accordance with B.3.1. to 3.5. and the annex.

*General administrative regulation on principles for the implementation of official monitoring of compliance with the provisions of food law, animal by-products law, wine law, animal feed law and tobacco law.

D. Collection of further data

The collection of further data beyond the registration according to section B and the collection according to section C, insofar as they are useful for the fulfillment of the tasks of the competent authorities, remains unaffected.
